DECISION

On the Establishment of the Working group of the Commission on Ways to Address the Issue of Providing Internally Displaced Persons with Housing

In accordance with Article 24 of the Law of Ukraine "On Temporary Investigative Commissions and Temporary Special Commissions of the Verkhovna Rada of Ukraine," a special commission carries out its activities in accordance with the requirements of this Law, the Law of Ukraine "On Committees of the Verkhovna Rada of Ukraine."

Article 15 of the Law of Ukraine "On Committees of the Verkhovna Rada of Ukraine" establishes that a committee, when exercising its legislative function, has the right, in particular:

- to establish working groups and appoint their heads from among the members of the committee in order to prepare drafts of acts of the Verkhovna Rada of Ukraine, issues discussed at committee meetings, draft decisions, recommendations, committee conclusions;
- to include in the composition of the working group members of the committee, other members of the Verkhovna Rada of Ukraine, employees of scientific and research institutes and educational institutions, authors of draft legislative acts, and other experts with their consent;
- to involve specialists on a contractual basis in the work of working groups with payment from the funds provided for in the budget for the exercise of the powers of the Verkhovna Rada of Ukraine;
- to involve officials and employees of state bodies and local self-government bodies in the work of working groups with the consent of the head of the respective body.

On December 22, 2023, the Temporary Special Commission of the Verkhovna Rada of Ukraine on the Protection of the Property and Non-Property Rights of Internally Displaced Persons and other persons affected by the armed aggression of the Russian Federation against Ukraine (hereinafter - the Commission) approved the Work Plan of the Commission (Appendix 1 to Minutes No. 1 of the Commission meeting dated December 22, 2023), according to which one of the main tasks of the Commission is, in particular, to initiate audits, monitoring, inventory, and search for possible options for providing internally displaced and other affected persons with

housing or social housing suitable for living, improving mechanisms for preferential lending, mortgages for the purchase of land plots, purchase, and construction of housing, application of other financial and credit mechanisms aimed at compensating damages to these persons, as well as the development of draft legislative acts aimed at strengthening the protection of the property and non-property rights of internally displaced and other persons affected by the armed aggression of the Russian Federation against Ukraine.

As a result of the consideration of the aforementioned issue, the *Commission* **d** e c i d e d:

- 1. To establish the Working Group of the Commission on Ways to Address the Issue of Providing Internally Displaced Persons with Housing (hereinafter the Working Group of the Commission) and elect Member of Parliament of Ukraine, member of the Commission, Maksym Mykolayovych Tkachenko, as the head of the Working Group of the Commission.
- 2. Members of the Commission who wish to join the Working Group of the Commission shall notify the Chairperson of the Commission within three days by submitting relevant appeals.
- 3. To invite (engage) representatives of central executive authorities, public, volunteer non-governmental organizations, as well as representatives of international humanitarian organizations to join the composition of the Working Group of the Commission.
