**DECISION**

**On the Draft Law of Ukraine “On Ensuring the Rights and Freedoms of Internally Displaced Persons” (new version)**

Based on the results of the Parliamentary and Public Forum “Strengthening the Protection of the Rights of Internally Displaced Persons” held in Khmelnytskyi region on 21-23 October 2024, where the draft Law of Ukraine “On Ensuring the Rights and Freedoms of Internally Displaced Persons” (new version) was presented and discussed, the Commission **d e c i d e d**:

1. To take note of the Analytical Report on implementation of the provisions of the Law of Ukraine “On Ensuring the Rights and Freedoms of Internally Displaced Persons” prepared by the Secretariat of the Commission and set out in Annex 1 to this decision.

2. To recognise as unfulfilled measure 2 of task 1 of strategic objective 1 of the Operational Action Plan for the implementation in 2023-2025 of the State Policy Strategy on Internal Displacement for the period up to 2025, approved by the Order of the Cabinet of Ministers of Ukraine dated 07 April 2023 No. 312-p, which should have resulted in the submission by the Cabinet of Ministers of Ukraine in the third quarter of 2023 to the Verkhovna Rada of Ukraine of a draft law on the implementation of the rights and freedoms of internally displaced persons in terms of strengthening targeting, taking into account the financial, economic and property status of such persons.

To address the Prime Minister of Ukraine in this regard with a proposal to take appropriate response measures.

3. To approve the draft Law of Ukraine “On ensuring the rights and freedoms of internally displaced persons” (new version), as set out in Annex 2 to this decision, and to send this draft law to the Prime Minister of Ukraine with a request to send it to the relevant central executive authorities, as well as to the regional authorities, Kyiv city state (military) administrations with a request to send it to the relevant district state (military) administrations, territorial communities of the region and 2 all the Councils on IDPs of the region for appropriate processing and submission of proposals and recommendations to the Commission by 14 November 2024.

4. The decision of the Commission shall be sent to the Prime Minister of Ukraine, heads of regional and Kyiv city state (military) administrations.
