WORK PLAN

of the Temporary Special Commission of the Verkhovna Rada of Ukraine on the protection of property and non-property rights of internally displaced persons and other persons affected by the armed aggression of the Russian Federation against Ukraine

- 1. Ensuring an increase in the number of internally displaced persons receiving accommodation allowance, introducing fair criteria for the payment of such allowance, taking into account the assessment of the needs and degree of integration of the internally displaced person at the place of his/her actual residence, extending the period of payment of such allowance until the end of martial law or until the proper level of integration of the internally displaced person into the new community is achieved.
- 2. Extending the mechanism of compensation for damage and destruction of certain categories of real estate as a result of Russian aggression to the objects located in the territories of Ukraine occupied since February 2014.
- 3. Providing internally displaced persons and other Ukrainians affected by the Russian aggression with residential or social housing suitable for living, improving the mechanisms of preferential lending, mortgages for the purchase of land, purchase and construction of housing, and other financial and credit mechanisms aimed at solving the housing problem of the affected persons.
- 4. Developing and implementing measures to bring Ukrainians abroad back to Ukraine, as well as maintaining ties with Ukraine for those Ukrainians who remain abroad.
- 5. Ensuring the implementation of the Law of Ukraine No. 4080-IX "On Amendments to Certain Laws of Ukraine on Additional Measures Related to the Provision of Housing for Internally Displaced Persons" (draft law 11281), conducting post-legislative control measures.
- 6. Ensuring the implementation of the Law of Ukraine No. 4114-IX "On Amendments to Certain Legislative Acts of Ukraine on the Priority Right of Certain Categories of Internally Displaced Persons to Receive Compensation for Destroyed Real Estate" (draft law 11028), conducting post-legislative control measures.

- 7. Ensuring the implementation of the Law of Ukraine No. 4071-IX "On the Keeping Record of Information on Damage to Personal Non-Property Rights of Individuals as a Result of the Armed Aggression of the Russian Federation against Ukraine" (draft law 10256), conducting post-legislative control measures.
- 8. Ensuring the implementation of the Law of Ukraine "On Amendments to the Law of Ukraine "On Compensation for Damage and Destruction of Certain Categories of Real Estate Objects as a Result of Hostilities, Terrorist Acts, Sabotage Caused by the Armed Aggression of the Russian Federation against Ukraine, and the State Register of Property Damaged and Destroyed as a Result of Hostilities, Terrorist Acts, Sabotage Caused by the Armed Aggression of the Russian Federation against Ukraine" regarding compensation for damage and destruction of certain categories of real estate objects located in the territories of military (combat) operations or temporarily occupied by the Russian Federation" (draft law 11161), and conducting post-legislative control measures.
- 9. Adoption of the new version of the Law of Ukraine "On Ensuring the Rights and Freedoms of Internally Displaced Persons", Draft Law, Reg. № 12301.
- 10. Monitoring the implementation of the decisions of the Temporary Special Commission of the Verkhovna Rada of Ukraine on the Protection of Property and Non-property Rights of Internally Displaced Persons and Other Persons Affected by the Armed Aggression of the Russian Federation against Ukraine (hereinafter referred to as the *Commission*) adopted in 2024.
- 11. Parliamentary work aimed at ensuring an adequate level of financial assistance, resolving housing issues, compensation for damage, losses and approaching reparations payments, promoting employment, access to social, educational, and medical services, effective solutions for adaptation, integration, evacuation, return to the abandoned place of residence and reintegration, meeting all basic needs for internally displaced persons, Ukrainian refugees abroad, and Ukrainians who remained in the temporarily occupied territory of Ukraine.
- 12. Ensuring the adoption of draft laws developed and initiated by the Commission in 2024, in particular:
 - On Amendments to the Law of Ukraine "On Ensuring the Rights and Freedoms of Internally Displaced Persons" regarding the payment of accommodation allowance based on the assessment of the needs and degree of integration of an internally displaced person at the place of his/her actual residence, reg. № 10382;

- On Amendments to Part One of Article 90 of the Budget Code of Ukraine on Financing Military Lyceums and Lyceums with Enhanced Military and Physical Training, Reg. № 12272;
- On Amendments to Article 5 of the Law of Ukraine "On the Status of Mountainous Settlements in Ukraine" regarding the protection of the rights of internally displaced persons, Reg. №12300.
- 13. Analyzing the practice of application and implementation of legislative acts on the protection of property and non-property rights of internally displaced persons and other persons affected by the armed aggression of the Russian Federation against Ukraine.
- 14. Developing draft legislative acts aimed at strengthening the protection of property and non-property rights of internally displaced persons and other persons affected by the armed aggression of the Russian Federation against Ukraine.
- 15. Holding parliamentary-municipal, parliamentary-public forums, as well as field meetings of the Commission in the regions.
- 16. Measures of parliamentary control over the observance of the current legislation and the validity, efficiency and expediency of decisions taken by state authorities and local self-government bodies to protect the property and non-property rights of internally displaced persons and other persons affected by the armed aggression of the Russian Federation against Ukraine.
- 17. Enhancing the level of provision of necessary information and awareness of internally displaced persons and other Ukrainians affected by the Russian aggression about support measures from the state, local governments, international and national humanitarian and other charitable organizations.
- 18. Improving legislation on the protection of the rights of certain categories of persons affected by Russian aggression, in particular, internally displaced persons, persons with disabilities as a result of war, veterans, children affected by war, persons missing and their families, persons residing in the temporarily occupied territories or the war zone.
- 19. Analyzing the implementation of the State Budget of Ukraine and local budgets in terms of efficiency and appropriateness of expenditures aimed at meeting the needs of internally displaced persons and other persons affected by the armed aggression of the Russian Federation against Ukraine, taking appropriate response measures.

- 20. Monitoring the implementation of the Operational Action Plan for the implementation in 2023-2025 of the State Policy Strategy on Internal Displacement for the period up to 2025, approved by the Resolution of the Cabinet of Ministers of Ukraine No. 312-p of April 7, 2023, taking response measures against responsible officials in case of failure to implement (improper implementation of) the relevant measures provided for by this Strategy.
- 21. Search for sources of funding and implementation of social housing construction (reconstruction, repair) projects.
- 22. Carrying out preliminary review and providing opinions on draft national programs, international treaties of Ukraine on the protection of property and non-property rights of internally displaced persons and other persons affected by the armed aggression of the Russian Federation against Ukraine.
- 23. Promoting the activities and development of the Councils for Internally Displaced Persons, strengthening the influence of internally displaced persons on decision-making at the national, regional and local levels.
- 24. Measures of inter-parliamentary cooperation to strengthen financial, humanitarian and other types of assistance to internally displaced persons and other Ukrainians affected by Russian aggression.
- 25. Consideration of appeals for the protection of property and non-property rights of internally displaced persons and other persons affected by the armed aggression of the Russian Federation against Ukraine.
- 26. Study of international experience in protecting property and non-property rights of internally displaced persons and other persons affected by armed aggression.
- 27. Development and approval of reports on the results of the Commission's work.
