**DECISION**

**On the establishment of the Working Group of the Commission for the prevention of corruption in the field of protection of the rights of internally displaced persons and the use of budgetary funds to meet their needs**

According to Article 24 of the Law of Ukraine ‘On Temporary Investigative Commissions and Temporary Special Commissions of the Verkhovna Rada of Ukraine’, a special commission carries out its activities in accordance with the requirements of this Law and the Law of Ukraine ‘On Committees of the Verkhovna Rada of Ukraine’.

Article 15 of the Law of Ukraine "On Committees of the Verkhovna Rada of Ukraine" stipulates that a committee, when exercising its legislative function, has the right, in particular:

- to create working groups and appoint their heads from among the committee members to prepare draft acts of the Verkhovna Rada of Ukraine, issues discussed at committee meetings, draft decisions, recommendations, and conclusions of the committees;

- to include in the working group members of the committee, other MPs of Ukraine, employees of research institutes and educational institutions, authors of draft legislative acts and other specialists with their consent;

- to engage specialists to work in working groups on a contractual basis with payment at the expense of funds provided for in the budget for the exercise of the powers of the Verkhovna Rada of Ukraine;

- to involve officials and employees of state and local self-government bodies in working groups with the consent of the head of the relevant body.

On 30 December 2024, the Temporary Special Commission of the Verkhovna Rada of Ukraine on the Protection of Property and Non-Property Rights of Internally Displaced Persons and Other Persons Affected by the Armed Aggression of the Russian Federation against Ukraine (hereinafter - the Commission) approved the Commission's Work Plan (Annex to the Commission's Decision of 30.12.2024), according to which one of the main tasks of the Commission is, in particular:

- monitoring the implementation of the Commission's decisions adopted in 2024;

analysing the implementation of the State Budget of Ukraine and local budgets in terms of the effectiveness and appropriateness of expenditures aimed at meeting the needs of internally displaced persons and other persons affected by the armed aggression of the Russian Federation against Ukraine, and taking appropriate response measures.

Following consideration of the issue, the *Commission decided*:

1. To establish the Working Group of the Commission on prevention of corruption in the field of protection of the rights of internally displaced persons and use of budgetary funds to meet their needs (hereinafter - the Working Group of the Commission) and to elect Oleh Oleksiiovych Arseniuk, Member of the Parliament of Ukraine, Member of the Commission, as the Chairman of the Working Group of the Commission.

2. To invite (engage) representatives of central executive authorities, public, volunteer non-governmental organisations, as well as representatives of international humanitarian organisations to join the Working Group of the Commission.
