DECISION

On the situation surrounding the purchase by the Lysychansk city military administration of the premises of the Druzhba children's camp (Kirovohrad region, Oleksandriivskyi district, Voynivka village) to accommodate internally displaced persons

At its meetings on 10 April and 23 October 2024, the Temporary Special Commission of the Verkhovna Rada of Ukraine on the Protection of Property and Non-property Rights of Internally Displaced Persons and Other Persons Affected by the Armed Aggression of the Russian Federation against Ukraine (hereinafter - the Commission) considered the situation surrounding the purchase by the Lysychansk City Military Administration of the premises of the Druzhba Children's Camp to accommodate internally displaced persons and decided, in particular, to hold a meeting of the Commission with the involvement of the Verkhovna Rada Committee on Anti-Corruption Policy .

On 12 February 2025, a joint meeting of the Commission and the Verkhovna Rada Committee on Anti-Corruption Policy was held with the participation of representatives of law enforcement agencies conducting (or who have conducted) a pre-trial investigation into the circumstances of the purchase of the children's camp premises by the Lysychansk City Military Administration, in particular, the Specialised Anti-Corruption Prosecutor's Office, the National Anti-Corruption Bureau of Ukraine, and the National Police, following which **the Commission decided**:

- 1. To ask the National Anti-Corruption Bureau of Ukraine and the Specialised Anti-Corruption Prosecutor's Office to inform the Verkhovna Rada Committee on Anti-Corruption Policy and the Commission on the results of the investigation of the relevant criminal proceedings by 1 May 2025 12023121060001545, taking into account the requirements for protecting the secrecy of pre-trial investigation.
- 2. To propose to the National Anti-Corruption Bureau of Ukraine and the State Audit Service of Ukraine to submit to the Verkhovna Rada Committee on Anti-Corruption Policy and the Commission proposals for amendments to the legislation to eliminate the preconditions for committing such offences.

- 3. To propose to the Prime Minister of Ukraine to strengthen control over the activities of military administrations regarding the use of budget funds aimed at providing housing for internally displaced persons and to introduce a mechanism for mandatory verification of the availability of the State Property Fund of Ukraine in the Unified Database and review of reports on the assessment of real estate and property complexes purchased with budget funds in order to prevent abuse and inefficient use of funds.
- 4. To address the State Audit Service of Ukraine with a proposal to conduct a state financial audit of the budgets of Luhansk region and Lysychansk territorial community for the period from 2022 to 2024 and, based on the results of the audit, to take measures to eliminate the identified violations and bring the perpetrators to justice, as well as to report on the current state of implementation of paragraph 4 of the decision of the Commission of 14 June 2024 "On the activities of the Luhansk regional military administration and city military administrations of the Luhansk region to meet the needs of internally displaced persons and the effectiveness of budgetary spending for these purposes".
- 5. To address the Committee of the Verkhovna Rada of Ukraine on Economic Development to take into account, when preparing the draft version of the Law of Ukraine "On Public Procurement" (Registration No. 11520) for the second reading, the proposal to expand its scope to cases of acquisition of real estate for budget funds.
- 6. To appeal to the National Agency for the Prevention of Corruption with a proposal to verify the property declarations of the heads of the Lysychansk City Military Administration and municipal enterprises involved in the acquisition of the premises of the Druzhba children's camp for the period from 2021 to 2024 in order to identify possible facts of illicit enrichment.
- 7. The Commission's decision shall be sent for proper response and consideration to the Prime Minister of Ukraine, the Head of the State Audit Service of Ukraine, the Director of the National Anti-Corruption Bureau, the Head of the Specialised Anti-Corruption Prosecutor's Office, the Head of the National Agency for the Prevention of Corruption, the Head of the Verkhovna Rada Committee on Economic Development, the Head of the Verkhovna Rada Committee on Anti-Corruption Policy.
